Subject: School Bus Transportation for 2009/2010 Academic Year

IC-International Concepts Corp (ICC) has provided student transportation to Atlanta area private schools since 1995. We are proud to kick off our third year offering our services to Wesleyan families. Our mission is to deliver safe and reliable transportation at a competitive price.

Bus routes operate from the first day of classes in August 2009 to the last day of school in May 2010. Enclosed are the Routes and Registration Form. IC-International picks up and drops off students at locations shown. We may make additional stops as long as vehicles do not deviate from main route. Please indicate on the Registration Form the bus stop that you wish to use, or call us at (678) 947-4969 to discuss the route or stop location best suitable for you.

**Summary of Our Capabilities and Benefits:**

**Submit Registration Now:**

Published routes are subject to changes in response to demand. If you plan to use our service this fall, please register immediately. This will accomplish the following:

- It guarantees a seat for your student; and,
- It guarantees IC-International's commitment to your route, stop location, and schedule, subject to reaching minimum number of riders for a route.

**Your Cost**

Your daily cost is \$8.50 for roundtrip transportation with noon departures on days so designated by the school. This cost is comparatively lower than that of equivalent services offered in this area for other private schools.

Contingency Cost Increase: If the retail diesel price increases over 30% from January to November 2009 prices, ICC may add a fuel surcharge to the annual fee. This surcharge, if necessary, will be due on December 1, 2009 and shall not exceed \$125 per family.

**Payment Plans and Processing of Registrations**

The Registration Form outlines two payment plans. The single payment option includes a \$60 discount.

We process registrations in the order received. If requested route is full, we will contact you to explore alternatives. Once a route is full, we place new registrations on a waiting list until we have sufficient demand to evaluate allocation of additional resources. Thus, if student transportation is important to you, please submit registration immediately.
